VA Education Benefits

The Joan and Art Barron Veterans Center certifies *Montgomery Gl Bill* (Ch. 30), *Vocational Rehabilitation* (Ch. 31), *Post 9/11 Gl Bill* (Ch. 33), *Dependents Educational Assistance* (DEA Ch. 35), and *Montgomery Gl Bill Selected Reserve* (MGIB S-R Ch. 1606).

Certification Process

- Proof of Eligibility
 - Montgomery GI BIII / Post 9/11 GI Bill: Certificate of Eligibility (COE).*
 - ➤ Voc Rehab: VA Form 1905*
 - ➤ MGIB S-R: Notice of Benefits Eligibility (NOBE)
 - > DEA: DEA VA Letter

*Post 9/11 and 1905 will defer tuition enabling student to register for classes without payment

- After Registering for classes, please provide supporting documentation
 - > Student Responsibility Agreement (SRA) (Required every semester)
 - <u>www.sdsu.edu/veteransra</u> (pdf download)
 - > 1995/5495 (First semester using benefits or changing majors)

- Certification Time Frames
 - ➤ Upon receipt of your SRA, standard certification may take 10 15 business days.

Cal Vet Fee Waiver

Apply after federal tax day in the spring for the upcoming academic year.

Academic year = Fall, Spring and Summer semesters
Application Period = April 18, 2018 for '18-'19 Academic year

Cal Vet Requirements

- Veteran must have at least a 0% disability rating
- Student must be a California resident*
- Income threshold = Poverty line for income

Out-of-State tuition deferment

Students using Post 9/11 GI Bill or Montgomery GI Bill may receive a deferment for out of State tuition under the following circumstances:

Service members separated within 36 months of the first date of term (Deferment also extended to dependents of service members eligible for Post 9/11 GI Bill)

- Must Provide DD 214 of service member
- Student's certificate of eligibility
- Verification of student's physical address (CA ID Card, utilities statement, rental agreement and or lease)

Active duty service members and their dependents eligible for Post 9/11 GI Bill may receive a deferment of out of State tuition provided the following documentation:

- Copy of service member's most current orders
- ❖ Memorandum from service member's Commanding Officer
- Student's certificate of eligibility
- Verification of student's physical address (CA ID Card, utilities statement, rental agreement and or lease)

Active duty service members <u>stationed in California</u> may receive a military exemption of out of State tuition provided the following documentation:

- Copy of service member's most current orders
- Memorandum from service member's Commanding Officer
- Verification of student's physical address (CA ID Card, utilities statement, rental agreement and or lease)

SDSU's Prospective Student Center and Office of the Registrar will grant deferment provided the documentation listed above.
