

Dear Students, Faculty and Staff,

We know some members of the San Diego State University community have both questions and concerns about planned immigration enforcement actions as U.S. Immigration and Customs Enforcement officials intend to pursue the arrest of thousands of individuals who are undocumented as early as this weekend.

SDSU will strongly support the success, safety, and well-being of all members of our community, no matter their immigration status. Also, with this message, we are sharing information intended to answer questions and help facilitate a process that will connect students, faculty and staff with academic, legal and other support, as they need assistance.

## **RESOURCES FOR BOTH STUDENTS AND EMPLOYEES**

The **Undocumented Resource Area (URA)** is a part of the Office of Educational Opportunity Programs (EOP). URA provides undocumented students guidance and support in navigating the campus and local community resources to support their well-being and enhance their educational achievement and timely progress toward a university degree. The URA is open to all undocumented students (including those with mixed-status families), faculty/staff and allies as well as the community at large. The **San Diego Rapid Response Network (SDRRN)** is a coalition of human rights and service organizations, attorneys, and community leaders dedicated to

aiding immigrants and their families in the San Diego border region. The SDRRN was activated to respond to increased immigration enforcement activities within San Diego County and humanitarian issues arising at the border, including widespread family separation and unjust deportation of asylum seekers presenting at the Port-of-Entry.
