Prospective Student Application

Mission:

The SDSU Guardian Scholars (GS) Program is a holistic support program committed to serving students who identify as current or former foster youth, wards of the court, under legal guardianship or unaccompanied homeless youth by supporting their transition to, through and beyond SDSU.

Eligibility Requirements:

- Be a highly motivated student who identifies as current or former: Foster Youth, Ward of the Court, Under Legal Guardianship, Unaccompanied Youth
- Qualify for undergraduate admission to SDSU as a freshman or transfer student
- Apply to the Educational Opportunity Program (EOP). To access the EOP application, go to: calstate.edu/apply
- Be a California Resident
- Qualify for "Independent Student" status under federal financial aid guidelines
- Apply for financial Aid by completing the Free Application for Federal Student Aid (FAFSA) at www.fafsa.ed.gov
- If eligible, apply for the Chafee Grant by March 2nd at www.csac.ca.gov. Apply for Cal Grant by completing the Cal Grant GPA Verification Form, also at www.csac.ca.gov
- If you meet one of the two criteria below, you DO NOT qualify for the SDSU Guardian Scholars Program. If at the age of 18, your legal status was or is:
 - Legally Adopted
 - Reunited with your biological parent(s)

Program Requirements:

- Complete EOP First Contact Orientation: June 2021
- Participate in the [EOP Summer Bridge Program](#), for first-time freshman: July 8th - August 13th, 2021. For more information about Summer Bridge, please visit eop.sdsu.edu
- Sign and commit to the GS Partnership Agreement (on page 4), stay in good GS Standing, complete the GS Semester Success Guide, and engage in the Guardian Scholars Community

- A McKinney-Vento Act from a school district liaison
- A letter/statement from a director of an emergency shelter program
- A letter/statement from a director of a runaway or homeless youth basic center
- A letter/statement from a director of a transitional living program

- Enroll in 12 or more units each fall and spring semester attending
- Maintain continuous good academic standing with a minimum overall 2.0 GPA
- Meet with your EOP Counselor at least twice per semester
- Complete the Guardian Scholars Semester Success Guide each semester, which includes these mandatory events:
 - Fall & Spring Kickoff – Day before each semester starts
 - Thanksgiving Celebration Dinner – Thursday before Thanksgiving holiday
 - GS Graduation Celebration Dinner – End of April

 - Actively participate in the EOP SOAR Mentor Program
 - Attend mandatory Guardian Scholars events each semester (i.e. Thanksgiving Dinner, Fall /Spring Kickoffs, Graduation)

- Beginning in fall 2021, enroll in 12 or more units each fall and spring semester
 - Maintain continuous good academic standing with a minimum overall Grade Point Average of 2.0
 - ▶ If I am not making satisfactory progress at the end of each term I will meet with a Guardian Scholars staff to develop a support plan to improve my academic success

- Additional:**
- Submit a Free Application for Federal Student Aid (FAFSA) no later than mid-November every academic year
 - Seek and apply to scholarships to help fund my educational journey

I understand and agree to the following:

- If I fail to meet any **one** of the agreements listed above I may lose the privilege and benefits of participating in the SDSU Guardian Scholars Program which include scholarships, housing and other support services available only to Guardian Scholars.
- ▶ If at the end of any academic year it is found that I am not meeting the above requirements, a hold will be placed on my GS scholarship disbursement(s) for the subsequent semester until I develop a support plan with Guardian Scholars staff.
- Per federal and state financial aid requirements, I must immediately notify the Office of Financial Aid and Scholarships (OFAS) of any scholarship or grant I have been awarded (such as Chafee), and any such award I receive must be accounted for in the determination of my eligibility for financial aid.
- As needed, should I receive a new grant or scholarship, OFAS will adjust my award in the following order: student/parent loans, work-study, grants, excluding Federal Pell Grant, then need-based scholarships.
