Satisfactory Academic Progress (SAP) Appeal

You are allowed to submit only one appeal for your degree program. Before completing and submitting this appeal, read all of the instructions and review the Satisfactory Academic Progress (SAP) requirements in the "Academic Progress" section of the website: sdsu.edu/financialaid. Lack of knowledge of the SAP requirements will not be grounds for submitting an appeal.

If you have failed to meet Satisfactory Academic Progress (SAP) requirements, you may appeal your ineligibility for financial aid. You may use this appeal if:

- you have not completed at least 75% of the units you attempted summer, fall, and spring; and/or
- your **grade point average** (GPA) is below the minimum SAP standard
- Do not use this appeal for a Maximum Unit related ineligibility

Note: Repeating a course more than once for course forgiveness that you previously completed with a D- or better, does not count toward the completion of 75%.

Instructions

Your appeal must be based on extenuating circumstances beyond your control that affected your ability to satisfactorily complete your classes. If you did not have extenuating circumstances, you may regain financial aid eligibility by using your own resources to attend and complete coursework until you meet the SAP standards.

Extenuating Circumstances

Extenuating circumstances beyond your control that may be considered with supporting documentation might include:

- personal injury or illness that required extended recovery time or significant improvement;
- death or illness of immediate family member; or
- significant trauma in your life that impaired your emotional and/or physical health.

Explanation and Documentation

- In a signed letter of explanation ***no longer than one page***, explain what happened that contributed to you not making progress towards finishing your degree, and what you will be doing moving forward to get back on track academically & make progress towards degree completion.
- If you are appealing due to your GPA falling below the minimum requirement, you must submit a letter of support from your Major Advisor, Assistant Dean for Student Affairs, or an EOP Counselor.
- If you meet with an advisor in the Office of Advising & Evaluations, please mention this in your appeal, and ask them to email us documentation of your visit.
- If an illness or injury, provide medical documentation that includes the date(s) of the illness and treatment. Include a statement signed by your doctor, on his/her letterhead addressing the situation and your ability to return to school. If you are registered with Student Ability Success Center (SASC), provide a letter of support from your SASC counselor.
- If a death in your immediate family, include a death certificate or obituary (include relationship to you).
- Include police reports or attorney statements if appropriate to support your circumstances.
 - Submit everything related to your appeal at the same time. Incomplete information or documentation may result in a denied appeal.
 - Once submitted, your appeal will be evaluated and a decision made within 4-6 weeks. The result of our review will be in the "Message" section of your AidLink record.

I further understand that I am responsible for paying university charges that may have been postponed before I became ineligible because I failed to make satisfactory academic progress and, I may need to pay tuition and fees to be able to register at my assigned time.
